We are committed to treating the whole person based on an integrated delivery system of client-centered primary care, mental health, education and wellness, and case management and support services.

Alder Health provides comprehensive health care in four (4) core areas:

Primary Care – quality medical care in a comfortable setting that is open and affirming. A special emphasis is placed on providing services addressing health disparities affecting the LGBTQ+ community and also hormone replacement therapy (HRT) for transgender individuals.

Behavioral Health – commitment to treating the whole person based using strengths-based and client centered services including individual and couples counseling, transgender inclusive services, psychiatric services and assessment, and medication management.
